CONSTRUCTION

Window

- The window has extruded aluminum sides around voice tubes which surround the vertical and top edge of bullet resistant glazing.
- Window glazing materials help to protect against Threat Levels 1, 2 or 3 based on UL752 ballistic standards for specified bullet resistance.
- The bullet resistant protection level may be specified by the end user and be consistent with the threat level.
