PRODUCT DESCRIPTION

The Insulgard Rotary Package Passer is constructed from materials designed to help combat ballistic assaults from Level 1 handguns per UL752 Ballistics Standards. The revolving inner package passer rotates from side to side, allowing packages to be passed through the barrier without a breach of security.

CONSTRUCTION

Box Construction

- An outer rectangular shaped shell is lined with bullet resistant materials and features openings at two sides.
- The interior revolving three-sided radius unit is also constructed from bullet resistant material plus a clear vision on the fourth side. The unit revolves back and forth from customer side to secure side, providing a package passer function. A ball bearing mechanism allows for easy rotation.
- Tops and bottoms are UHMW plastic.
- Hardware is stainless steel including crank handle.

Glazing Materials

- Glazing materials are rated based on UL752 Ballistics Standards for specified bullet resistance.
- Bullet Resistant Glazing
UL Level 1: 1 1/4" Acrylic
