# CONSTRUCTION

#### DOOR

- The door system is constructed from a single sheet of acrylic with a standard UL752 Level 1, 2 or 3 rating.
- For the half vision door, a variety of plastic and metallic laminates are available to match surrounding materials in a lower opaque door panel.

#### FRAME

Door frames are constructed from a 1¾" x 4" non-rated aluminum slick tube. The frames are completely fabricated and shipped for field installation. All joint connections have a concealed shear block to provide a rigid assembly when installed. Optional rated frames are available.

#### HARDWARE

- Heavy duty continuous hinge
- ADA Overhead surface closer
- ADA Lever lockset
- Anti-Jimmy plate for out swinging doors
- Two piece door stops
- Electric strike release system (optional)
- Optional: Accessories such as metallic kick plates and transoms

- Standard: Clear anodized aluminum and dark bronze anodized aluminum
- Custom: Anodizing or baked enamel paint finishes are available. Custom finishes may affect delivery times.
